

### CFA Program Costs\*







# CHANGES TO THE CFA PROGRAM FOR 2024

### **Eligibility Change**

We have expanded program eligibility rules for those in university. Those who are **two years away from completing their undergraduate degree** may now register.

#### **Benefits**

- Providing students with the opportunity to prepare for internships and investment careers while still studying.
- Adding a practitioner perspective to academic studies.
- Stand out in graduate recruitment a clear signal to employers that students are serious about a career in the investment industry.



To avoid repetition of undergraduate learning, foundational content on Economics, Statistics, and Accounting has been moved out of the Level I curriculum, reducing the core study material for Level I by about 12%.

CFA Level I candidates who do not have a basic understanding of these concepts or would like to review them can study from any of the three prerequisite-reading volumes

### **Practical Skills Modules**

The CFA Program has been expanded to include practical, relevant skills training to provide candidates with direct application of what they are learning in the curriculum.







Each candidate will be able to choose a "specialized pathway" comprising 30% of their study material.






An annual global competition that provides university students with hands-on mentoring and intensive training in financial analysis
